a) customized outfitting exceeding the max. admissible height of 3.00 mt. (maximum permissible height of free standing stand 5.50m from the ground; maximum permissible height of suspended structures 6m from the ground); b) two-level stand (please see also the Technical Regulations on the Exhibition). **The stand designs must be strictly North oriented**

Please remember that:

- 1) during the outfittings, the exhibition centre corridors must remain free of any materials, goods or wrappings. All obstructing materials will be collected and removed by Fiere di Parma and the service will be paid by the exhibitor according to prices of form F2 and F3 plus a €500,00+ VAT penalty that the exhibitor undertakes to pay also in case this is caused by his contracted outfitting company.
- 2) **IT IS STRICTLY FORBIDDEN FOR EXHIBITORS OR FITTERS TO ACCESS FORK LIFTS, MOBILE CRANES, AERIAL PLATFORMS, ETC. INSIDE THE EXHIBITION CENTRE. IN CASE OF BREACH, Fiere di Parma shall immediately stop the equipment and order its removal; THE EXHIBITOR SHALL BE SUBJECT TO A FINE OF € 1000.00.**
- 3) Containers of paint, leftover carpeting and tape on the floor shall be compulsorily disposed of by the Exhibitor/Fitter. In case of breach of this provision, Fiere di Parma shall automatically charge Exhibitors the expenses borne for removing and disposing of these materials in addition to a fine of € 1000.00.
