Moreover, for indirect exhibitors and outfitters shall comply with the following provisions: Submit an identification document and pay a deposit (non interest-bearing) of € 300.00.

The effective activation of the booked service must be required on site directly to the official handling company

3. For handling services during the dismantling phase, a fee will be charged as advance payment, corresponding to 80% of the handling operations carried out during the outfitting. At the end of the event, any excess and/or balance will be charged.
